- A. Friends of Collier Township Parks and Recreation Cupples reported that the Friends Board is planning a bake sale for April 26th during primary elections at the Municipal Building. The Board is coordinating with Chartiers Valley School district for an art show. The luau event has been moved to 2017 (possibly).
- B. Molly's Dog Park Eckenrode noted that the topic of the parks location is a topic that will be discussed at the February 24, 2016 Collier Township Board of Commissioners meeting. He encouraged everyone to attend. To date \$7,640.80 has been raised for the construction of Molly's Dog Park.

- Public Works Director position has been advertised and we have secured 28 applications. The Commissioners are completing the interview process and will name a Director soon.
- Discovery Path at Hilltop Park Contract has been bid, bids have been received and we anticipate awarding at tomorrow's Workshop meeting.
- Molly's Dog Park at Collier Park BOC reviewing bids and projected shortfalls and reviewing Collier Park location.
- Hilltop Park anticipate project to start as the weather breaks first part of the project will be installation of restrooms.
- Hilltop Park Ribbon Cutting –summer
- County Infrastructure and Tourism Fund Grant application has made for demolition of two of the remaining buildings at Collier Park \$155,019. Which will require a Collier match of \$20,000.
