- **I. CALL TO ORDER:** Commissioner Macino called the workshop meeting of the Board of Commissioners to order at 7:03 P.M.

- **C. EXECUTIVE SESSION:** Executive session was held prior to the meeting to discuss personnel issues.
- D. Kristen Michaels, Executive Director CONNECT

Ms. Michaels was invited by Mr. Thauvette to come speak to the Board about the group CONNECT.

CONNECT is a membership organization and was stated in 2009 by David Miller to bring together the City of Pittsburgh and local municipalities that border the City. They meet once a month and rotate to the different municipalities who are members to hold their meetings. All the members get together to discuss different subjects such as transportation, sewers, blight and abandonment, gun violence, etc. Each subject then has a committee to gather information and discuss the issue on more detail and then bring it back to all of the members. The entire membership would then hear the information and decided if a Resolution should be passed.

There are membership dues which are based off of population of the municipality. Collier's membership dues would be \$570 a year. They also offer a six (6) month trial period if we don't want to commit to a membership. To become a member, we need to let her know if we are interested and the Board of Commissioners would

need to pass a Resolution to commit to a membership. Then the Commissioners would appoint three (3) members (the Manager and two (2) elected officials) to attend the meetings during the day.

Ms. Michaels informed the Board they are having a fundraiser/networking event at the Hitchhiker Brewery in Sharpsburg and they are welcome to attend.

Commissioner Chiurazzi questioned why this would benefit Collier?

Ms. Michaels stated for the networking and the quick access to important people/communities.

Commissioner Chiurazzi questioned if this could take the place of a COG?

Ms. Michaels stated no. CONNECT will never do joint purchasing. They will not take the place of a COG.

Commissioner Chiurazzi questioned what is the connection with PITT?

Ms. Michaels stated the offices are located at PITT.

Commissioner Durisko questioned how many times a Resolution is passed and are they binding or just for guidance.

Ms. Michaels stated Resolutions are passed once a year and they are not binding.

Commissioner Durisko questioned who decides the budget.

Ms. Michaels stated the memberships decide and along with the budget monies, we also get grants to pay for projects.

The Board of Commissioners thanked Ms. Michaels for coming.

## II. PUBLIC COMMENT ON NEW BUSINESS ITEMS:

**Frank Noble** of 500 Azalea Lane approached the Board to thank them for working with the Developer of Neville Park. Mr. Noble would like to see the tracking of fines for the Developer.

Commissioner Macino stated the assessments are through the Magistrate. We will find out from the Manager, Mr. Thauvette and let Mr. Noble know.

# A. Administrative Committee/Public Affairs:

# C. Finance Committee:

Commissioner Macino reported the 2019 Budget is in fine tuning. It was advertised and ready for review. It can be viewed on the website or at the Township Administration Office.

## D. Parks and Recreation:

Mrs. MaryAnn Cupples-Wisnoiski of the Friends of Collier Board reported she attended the meeting. Mr. Tim Eckenrode interviewed three (3) people to fill the vacant seats on the Parks and Recreation Board. There has not been a final decision.

The Friends of Collier board raised \$400.00 for the Dog Park with their 50/50 drawing they held on election day.

The Friends of Collier Board also gave the Township a \$500.00 donation for trees at Hilltop Park.

## E. Planning and Zoning:

Commissioner Williams-Zabicki reported the following:

- 1. Public Hearing on December 12, 2018 at 6:30 p.m. for the SALDO regarding emergency access roads.
- 2. Carpenters Union 6,000 sq. ft. addition. The Planning Commission recommends approval.

# F. Public Safety Committee:
