- IX. Parks & Recreation Department Report by Josh Werner:

Josh Werner announced that he has turned in his resignation to the township manager and his last day will be Friday, Nov 4. Josh will be the new Parks & Recreation Director for Moon Township. Board members wished Josh well in his new position,

thanked him for all he has done for Collier Township, and noted that he will be greatly missed.

The name for Collier's yearly *Light Up Night* must change as we have been notified by the City of Pittsburgh that they have trademarked that name and Collier is not permitted to use it. A new name has not yet been chosen but the event will occur on Friday, Dec 2nd, from 6 – 8 pm.

The Veterans Brunch will be held on Nov 10th. So far, there are 20 – 30 people signed up. Keynote speakers are 21-year Marine Veteran Craig Hodgkins along with medical service dog, Foxy, and Matthew Romanishin who is a US Army veteran and licensed Clinical Social Worker for the VA.

Help is needed at the Front Desk especially for nights and weekends.

The resurfacing of TJ Court has been completed.

Cracks in Webb Park have been patched although other work at this park still needs to be performed.

Approximately \$100,000 in program fees have been collected. The Parks and Recreation Department is on track for one of the best years ever.
