The Officers continued to assist with life savings efforts. The patient was transported to St. Clair Hospital where the patient recovered from this event.

Chief Campbell gave them Certificates of Accommodation.

Richard Trail of 705 Stonegate Drive approached the Board with concerns about speeding in his neighborhood of Rennerdale Highlands and not stopping at the stop signs. The offenders are adults and not teenagers. He has tried to address this situation with the police and has come up to the building a couple of times to talk to a police officer and the administration. Nothing has happened and wants to know what help can be given.

Commissioner Zymroz asked what the speed limit was.

Mr. Trail stated residential is always 25.

Chief Campbell stated it is 35 unless it is posted and a neighborhood like this is most likely 25.

Commissioner Chiurazzi stated speeding and not stopping at stop signs is everywhere. The Commissioners can not do anything about it. If a police officer is near there and sees it will do something, but we are limited in people power and this is a big Township.

Commissioner Chiurazzi stated he has the same issues in his area and we have put up a speed sign and do what we can.

Mr. Trial stated the speeding is happening when people are coming and going to work and asked if an officer could be there.

Chief Campbell stated we are dealing with the same issues in Tuscany Ridge and Amalfi Ridge and we will add Rennerdale Highlands to the list.

Mark Lewis of 1212 North Gray, Bridgeville, PA, approached the Board thanking them for honoring the police officers and EMS people. They worked long and hard to make sure that gentleman would survive to come to this meeting. It means a lot to them and us.

VIII. New Business:

 Consider action to grant final land development approval to Eat'n Park contingent upon providing a shared parking agreement meeting the approval of the Township Solicitor and satisfactorily addressing the items listed in the Township Engineers review letter dated December 13, 2022. 6. Consider action to approve the James Moretti final subdivision application with the condition of addressing all items in the January 17, 2023 Township Engineer review letter.

Mr. Caun stated this is a small five (5) lot subdivision off of South Cowan Road.

7. Consider action to approve Resolution No. 012323-04, a Resolution to amend the official sewage facilities plan to include the James Moretti Plan of Lots.

Motion was made by Commissioner Chiurazzi, seconded by Commissioner Vaughn, to approve Resolution 012323-04 as stated above. By unanimous vote, the motion passed.

8. Consider action to appoint the Post-Gazette as the Collier Township official newspaper of record for public advertising in 2023.

Commissioner Cupples questioned if this is the only option we have.

Mrs. Slizik asked Ms. Salla to answer.

Ms. Salla stated at a prior meeting, the board added the Almanac for advertising and we found out they are very pricy. The Post-Gazette has been printing even though they are on strike and are still cheaper.

Motion was made by Commissioner Chiurazzi, seconded by Commissioner Young, to appoint the Post-Gazette as stated above. By unanimous vote, the motion passed.

9. Consider action to accept the resignation of Tom Chidlow from the Planning Commission effective immediately.

Commissioner Chiurazzi thanked Tom Chidlow for all his years of service.

Commissioner Cupples also thanked Tom Chidlow for all his years of service.

Motion was made by Commissioner Zymroz, seconded by Commissioner Young, to accept the resignation of Tom Chidlow as stated above. By unanimous vote, the motion passed.

10. Consider action to appoint Dave Abbott to the planning commission for a four-year term effective January 23, 2023 and ending December 31, 2026.

12. Consider action on bond reduction request No. 1 from 76 Development, LLC. for Creekside Meadows. Township Engineer LSSE has reviewed the request and recommends the Township reduce the bond amount from \$2,207,468.18 to \$420,758.25, which is 110% of the total cost for the remaining improvements.

Motion was made by Commissioner Chiurazzi, seconded by Commissioner Cupples, to approve the bond reduction request No 1 from 76 Development, LLC as stated above. By unanimous vote, the motion passed.
