GRADING - THE APPLICATION AND ESCROW FEES SHALL BE CALCULATED IN ACCORDANCE WITH THE TABLE BELOW:

<u>VOLUME OF EXCAVATION</u>	<u>FEE</u>
Not more than 1000 cubic yards:	\$ 100.00
More than 1000 cubic yards:	\$ 0.10 per per cubic yard.
Maximum Fee:	A maximum fee of \$5,000.00 shall be imposed.

Escrow Deposit for Plan Review and Inspections: Upon the initial submission of an application for grading, the applicant shall be required to submit a deposit according to the following schedule, from which any fees accruing during the permit review and inspections shall be deducted from the deposit.

<u>Volume of Excavation</u>	<u>Plan Review Escrow*</u>	<u>Inspections Escrow*- due at time of application approval</u>
250-1000 cubic yards	\$ 500.00	\$ 500.00
Over 1000 cubic yards	\$ 2,000.00	\$ 2,000.00

*At completion of project, any monies remaining after all fees have been deducted shall be returned to the applicant. If at any time the sum of all fees owed exceeds the amount in escrow, the applicant shall be required to pay the Township an amount equal to the balance. Permit may be withheld until such time that the remaining balance is paid and may be suspended until such time that the remaining balance is paid.

Permit Renewal Fee: \$500.00. Permit fees shall be doubled for work started without the issuance of a permit.
