1. Approval of December 15th, 2025, workshop meeting minutes.
2. Consider action to grant Preliminary and Final Major Land Development to Discount Tire with the condition of satisfactorily addressing all comments in the Township Engineers review letter dated January 6, 2026, and to recommend approval of the

requested waiver of SALDO Section 22-804 to eliminate the sidewalk extension along the common driveway with the condition that an accessible sidewalk be constructed in another location to allow pedestrian access to the public way, and to recommend approval of the requested waiver of SALDO Section 22-910.1.A.1 to permit less than 1.0 Footcandle measurement with the parking and pedestrian areas of the site when measured 3 feet above grade. The Planning Commission has reviewed and recommends approval.

3. Consider motion to accept recommendation from LSSE Engineering to award the 2026 O&M Cleaning and Televising contract [No. 26-S1 (Base bid, Alt. #1 and Alt. #2)] to State Pipe Services LLC at the bid price of \$118,021.25.
4. Consider action to amend the Official Sewage Facilities Plan to include the McGinnis Plan of Lots.
5. Consider action to amend the Official Sewage Facilities Plan to include 7-Brew Coffee Shop.
6. Consider action to set a public hearing date of Monday February 23, 2026 for the PRD application of Nixon Development LLC.

Consider action to set a public hearing date of Monday March 9 at 4:30 PM for the application of Collier Owner, LLC and Team Togo Leasing, LLC d/b/a PetVet 365, to amend the text of the Collier Township Zoning Ordinance to include "Specialty Veterinary Clinic" as a use by Special Exception in the B-3 Zoning District.
8. Consider action to approve Resolution No. 02-02-2026-09 amending the monthly sewer usage charges. Such charges shall be increased for the minimum service charge from \$9.24 to \$9.54, an increase of 30 cents, and for the usage rate per thousand gallons of water from \$18.90 per thousand gallons of usage to \$19.50 per thousand gallons of usage, an increase of 60 cents. This increase in sewer rates was previously approved through the Board's vote to approve the 2026 budget; however, this Resolution provides transparency and a basis of comparison and understanding for the Township's residents.
